### TUESDAY - December 11, 2018

### **Seating of New Members and/or Alternates**

One new IPCoMM member was in attendance: Percy Ballot of Buckland representing Maniilag Assn.

There was discussion on Bristol Bay Marine Mammal Council's representative to this meeting since Myra Olsen, BBMMC's chairperson, was in attendance in person, and Helen Aderman was on teleconference.

<u>MOTION</u>: Billy Adams moved that before next spring we should get some clear indication whether it's Helen Aderman or Myra Olsen representing BBMMC when attending IPCoMM meeting in person. Write letter to Ralph Andersen. Seconded by Tom Gray. Motion carried.

### Financial Report

Peggy Osterback, IPCoMM Secretary/Treasurer, reported on a meeting the previous day of the financial committee.

**MOTION**: Robert Henrichs moved to approve financial report. Seconded by Tom Gray.

Motion carried.

**MOTION**: Lianna Jack moved to change IPCoMM's fiscal year from September 1 – August 31

to October 1 – September 30. Seconded by Peggy. Motion carried.

**MOTION**: Tom Gray moved for IPCoMM to negotiate an indirect cost rate with NOAA.

Seconded by Helen Aderman. Motion carried.

#### **Chairman's Updates**

Chairman Mike Miller reported via teleconference. There have been several presentations to IPCoMM members from Udall Foundation and Native Nations Institute to help focus on potential shared services so we can leverage our funds and find deficiencies in communities.

IPCoMM had been working with NMFS and PSFMC on a Grant Writing Workshop in October. We have received good feedback from attendees from rural communities. Those who attended were those who have capacity for writing grants for ANOs possibly to Department of Commerce and others.

IPCoMM Chair was able to testify to Senator Sullivan's subcommittee related to the importance of maintaining the co-management language in the MMPA. We would like to introduce positive enhancements to the MMPA, both in funding and in scope.

We are talking with our attorneys about updating our documents, such as IPCoMM Conflict of Interest and references to BBNA/BBMMC.

The IPCoMM Umbrella Agreement is somewhat outdated and we may focus on a potential renewal of that in the spring meeting.

#### NMFS Updates

Pete Jones and Jenn Hall Brown updated on grants-related information. Jon Kurland of NOAA Protected Resources reported. Dr. Jennafer Malek will be hired by them full time in March. NMFS is working with FWS on rulemakings of Endangered Species Act, Sections 4 and 7. Unusual marine mammal strandings have taken place in 2018, involving 8 beaked whales at Adak, numerous ringed seals along Aleutian Chain, and a Steller sea lion in Utqiagvik.

### **USFWS Updates**

Patrick Lemons of FWS Marine Mammals Management briefly updated on Polar Bear Co-Management, which is moving along well with the Alaska Nannut Co-Management Council. Next fall will be the next Russia Polar Bear meeting. FWS is about to finalize funding for new Pacific Walrus Research.

#### **GEOFENCING: Large Vessel Tracking in Subsistence Areas**

Aaron Poe and Lauren Divine reported on Arctic Vessel Monitoring, Geofencing and Alert Awareness. There is a need for active monitoring of vessels in the Arctic to determine if vessels are impeding subsistence marine hunting activities. ### Senator Dan Sullivan, Alaska Congressional Delegation

Kate Wolgemuth, Rural Advisor to Senator Sullivan, spoke about 116<sup>th</sup> Congress and that Senate Armed Services committee assignments are not out yet. There's an interest in additions to MMPA amendments in draft or bill form.

#### Marine Mammal Commission Co-Management Review Project Update

Presented by Dr. Jennafer Malek. A hand-out was distributed showing a summary of 2008 MMC Co-Management Review; 2008 MMC Co-Management Review Recommendations; Follow-Up to 2008; 2018 Review; Methods; Focus Groups and Interviews; Methods; Findings; Recommendations; Moving Forward; Management Implications.

### Ongoing Discussion of Shared Services Potential and Planning

By Dana Goodson of Udall Foundation and Miriam Jorgensen of Native Nations Institute. Two break-out groups were formed for discussions on services potential and planning.

# **Discussion of Potential MMPA Amendment Package**

Amendments to MMPA are recommended, since it is outdated. Three attempts by IPCoMM for amendments to MMPA have been done, primarily for harvest management plans. State of Alaska would always intervene in previous times, by not recognizing tribes. Amendments would possibly update funding caps. IPCoMM would work with Alaska Delegates.
